4. Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" *World Bank Procurement Regulations for Borrowers under Investment Project Financing, dated July*



1, 2016, setting forth the World Bank's policy on conflict of interest ("Procurement Regulations"), and is open to all Bidders as defined in the Procurement Regulations.
