Environmental Expert (individual) for “Implementing Sustainable Low and non-Chemical Development in SIDS (ISLANDS)”

The Ministry of Climate Change, Environment and Energy has received funding from the Global Environment Facility (GEF) towards implementing the project “Implementing Sustainable Low and non-Chemical Development in SIDS (ISLANDS)”, and intends to apply part of the proceeds to recruit a Environmental Expert who will be responsible to support the Project Management Unit (PMU) to ensure the project is completed within timeline and budgetary restrictions.
